

"SCOTTS LAW" MOVE OVER LAW WAS SIGNED BY GOVERNOR GEORGE RYAN AND WENT INTO EFFECT JANUARY 1, 2002

"DO YOU KNOW THE LAW"??????

- CHANGE LANES IF POSSIBLE - REDUCE YOUR SPEED - PROCEED WITH CAUTION







AUTHORIZED EMERGENCY VEHICLES

INCLUDES **ANY** VEHICLE AUTHORIZED BY LAW TO BE EQUIPED WITH OSCILLATING, ROTATING OR FLASHING LIGHTS UNDER SECTION 12-215 OF THE VEHICLE CODE.

AS OF JANUARY 1, 2017, WE NOW PROTECT ALL VEHICLES ON THE SHOULDER WITH FLASHING LIGHTS INCLUDING ALL COMMERCIAL TRUCKS AND PASSENGER CARS

SCOTT'S LAW = MOVE OVER SLOW DOWN

ISP BECAME THE NATIONAL FACE FOR THE MOVE OVER LAW

- Because of the issues our Department was facing, we saw this as an opportunity to draw attention to the FACTS ALL first responders and the motoring public face.
- Under Illinois Law, the Move Over Law (aka Scott's Law)
 - Requires motorists to change lanes out of the lane adjacent to the stopped emergency vehicle if possible
 - If not possible, they are required to slow down and proceed with due caution past the emergency vehicle
 - Covers Police, Fire, EMS, Construction, Tow and the public with 4-way flashers activated

ISP BECAME THE NATIONAL FACE FOR THE MOVE OVER LAW

- We tackled the issue with a three prong approach
 - Education
 - Enforcement
 - Legislation



EDUCATION

- ISP NEVER approached the issue from our sole perspective. The message was always about ALL first responders AND the public (because of how our law is written to include motorists with roadside emergencies).
- I'd like to tell you we sought out community partners to assist us in spreading our safety message, but we didn't have to. Requests to help started pouring into PIO.

LEGISLATION / EDUCATION

- Required the Secretary of State to include a question concerning Scott's Law on the written driver's test.

- Increased the minimum fine for a Scott's Law violation without damage or injury to a person or vehicle from \$100 to \$500.
- Makes a Scott's Law violation that results in damage to a vehicle a Class A Misdemeanor and a violation that results in injury or death a Class 4 Felony.

- Increased the penalty for a reckless homicide conviction based on a violation of Scott's Law that results in the death of a firefighter or emergency medical services personnel from a Class 3 felony (2-5 year prison sentence) to a Class 2 felony (3-7 year prison sentence).
 - This provision matches the penalty for reckless homicide for speeding in a construction zone and reckless homicide involving a police officer.

- Added Scott's Law violations to the list of aggravating factors that may be used in sentencing to impose a more severe sentence within the range allowed for the class of crime.
- Clarified the requirements of Scott's Law and approaching any non-emergency disabled vehicle.
 - The requirements for approaching any non-emergency disabled vehicle now match Scott's Law. The penalty for failure to properly approach a disabled vehicle remain a petty offense.


- A portion of the increased fines are directed into a new Scott's Law Fund to be used by Illinois State Police for education about Scott's Law and increased enforcement.
- Created the "Move Over Task Force", which will consist of dozens of law enforcement and transportation officials, to study the issue of approaching emergency vehicles, disabled vehicles, and highway construction zones. The task force will pay particular attention to the causes of violations and ways to protect law enforcement and emergency responders.

EDUCATION – SOCIAL MEDIA

2019 CRASH STATISTICS

- 22% of the crashes involved a DUI arrest
- 57% of the crashes involved a trooper injury
- Of troopers injured 69% had Type A injuries or worse
- The top Primary Contributory Cause was "Exceeding Safe Speed for Conditions"
- The top Secondary Contributory Causes were "Failing to Reduce Speed to Avoid Crash" and "Weather"

about a million, and many of them brought tears to my eyes.




