### CAPITAL PROGRAM OVERVIEW

#### **PROGRESS THROUGH 2019**

- Spent about \$7 billion since the program began in 2012
- Completed I-294/I-57 Interchange Project Phase 1
- Delivered \$2.5 billion I-90 Rebuilding and Widening Project
- Delivered Illinois Route 390 Tollway
- Reconstructed, rehabilitated or expanded seven maintenance facilities
- Completed systemwide roadway, bridge and ramp improvements; lighting upgrades; as well as landscaping, signage, noisewall and drainage work

#### **REMAINING WORK**

- Targeting nearly \$3 billion in spending in next three years
- Reconstruction of the Central Tri-State Tollway (I-294)
- Construction of the new I-490 Tollway
- Completion of the I-294/I-57 Interchange
- Construction and rehabilitation of facilities throughout the system
- Continue systemwide improvements to keep the Tollway's roadway network in a state of good repair

## CENTRAL TRI-STATE (2019-2025)

\$4 billion investment for congestion-relief and regional mobility needs

### **Regional Benefits**

- Congestion relief and increased travel time reliability
- Peak hour trips will experience an average of 20% shorter travel times
- New truck parking and improved freight mobility
- Regional stormwater solutions
- Coordination with communities to address access, safety, noise and economic opportunities



## CENTRAL TRI-STATE (2019-2025)

\$4 billion investment for congestion-relief and regional mobility needs

#### **Work Complete**

 Removal of the O'Hare Oasis needed to widen between Balmoral Avenue and Wolf Road in Franklin Park

#### **Work Underway**

- Repairing, resurfacing and widening I-294 to five lanes between
   Balmoral Avenue and Wolf Road in Franklin
   Park
- Reconstructing the Mile Long Bridge
- Reconstructing the BNSF Bridge


### Work Remaining

- Rebuilding and widening between North Avenue and I-55
- Reconfigure and improve the I-290/I-88 Interchange at I-294
- Rebuild and widen between I-55 and 95th Street
- Construct a new interchange at 88th/Cork Avenue

### I-490 TOLLWAY (2019-2025) Providing regional and western access to O'Hare

#### **A Critical Connection**

- Connecting businesses and communities with one of the nation's busiest airports, transit facilities, major freight transportation hubs, distribution centers and multiple interstate highways
- A "Project of National and Regional Significance" by federal transportation legislation
- Accommodate access into O'Hare via two new cashless Tollways
- 17 miles of new roads with 15 new or improved interchanges

- New partial interchange on I-294 at County Line Road/North Avenue (Illinois Route 64)
- Touhy Avenue improvements

### I-294/I-57 INTERCHANGE (2012-2014; 2019-2023) Connecting two major interstates

Opening up access to relieve congestion along local routes, enhance economic development and improve regional mobility.

#### The completed interchange will:

- Provide complete access
- Support new opportunities for the south suburbs
- Advance efforts toward greater regional mobility



## I-294/I-57 INTERCHANGE (2012-2014; 2019-2023)

Connecting two major interstates

#### Phase 1 Complete

- Completed in 2014
- Delivered 75% of project benefits
- Budgeted at \$380 million (jointly and equally funded by IDOT and the Tollway)

### Phase 2 Underway







#### Value of Unbundled Awards and Spend







### 2020 BUDGET

- Board of Directors approved a balanced 2020 Budget – \$1.54 billion in revenue to fund maintenance and operations, debt service transfers and capital investments
- \$1.46 billion commitment in capital spending,
- Funding for the ninth year of *Move Illinois*
- Plans to issue \$500 million in new bonds in 2020 for new and future capital investments
- A user-fee system that receives no state or federal funds for maintenance and operations





### **MOVE ILLINOIS** 15-year, \$14 billion capital program

The Illinois Tollway's 15-year, \$14 billion capital program, *Move Illinois: The Illinois Tollway Driving the Future*, will improve mobility, relieve congestion, reduce pollution, create as many as 120,000 jobs and link economies across the Midwest region.

### **CENTRAL TRI-STATE (2019-2025)** \$4 billion investment for congestion-relief and regional mobility needs

The Illinois Tollway is constructing two new, wider bridge structures to replace The Mile Long Bridge carrying drivers over two major railroads, three water resources and local roads, and over a major distribution center for UPS and Burlington Northern Santa Fe (BNSF) Railway. The bridge is a critical piece of infrastructure to the 22-mile Central Tri-State Tollway (I-294), which serves more than 220,000 vehicles daily and supports 43,000 direct and indirect jobs.

### I-490 TOLLWAY (2019-2025) Providing regional and western access to O'Hare

Save drivers \$145 million in time and fuel annually by 2040 Reduced delays by 24% on local roads Accommodate three times as many vehicles per day as local roads carry now More than 7 minutes less travel time between west side of O'Hare and Lake Street – a savings of 25%

By unbundling both professional services and construction projects, the Tollway identifies new opportunities for firms of all sizes, as well as increasing competition. This process also provides a mechanism to grow and graduate existing firms from a sub assignment to a prime contracting position.


#### Diversity

Since the start of *Move Illinois* in 2012, the Tollway has committed nearly \$2 billion to small, diverse and veteran firms, or more than 29% of the \$6.9 billion invested in the system. While these results are impactful, the Tollway is determined to expand the next generation of entrepreneurs looking to build and expand in the heavy highway business and build capacity.

#### **Procurement and Compliance**

The Illinois Tollway is taking strides towards strengthening the procurement and contract compliance process by consolidating and streamlining procurement efforts throughout the agency. These efforts include the following:

- Centralizing procurement by consolidating design, construction, goods and services into an integrated, more efficient and effective procurement department.
- Revising procurement processes and procedures to increase transparency, accountability and inclusion of small and diverse businesses.
- Implementing a comprehensive contract compliance program with increased monitoring and tracking of diversity goal commitments, enforcement of prevailing wage payments, and increased vendor assistance and training to ensure compliance with Tollway contract requirement.
